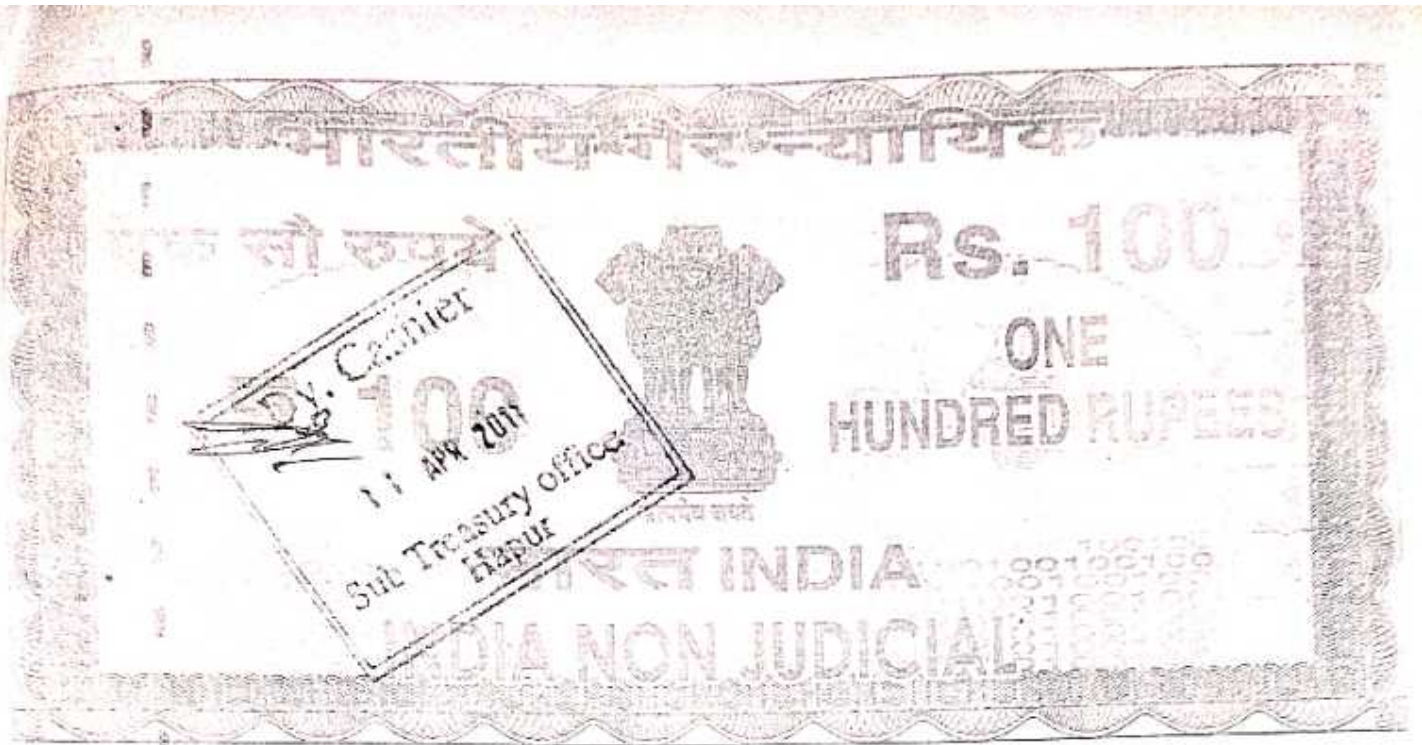

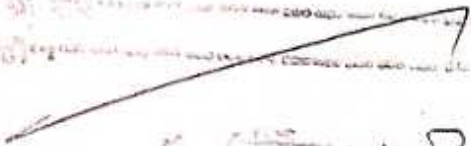

- l) To appoint or make provision for the appointment of any person (including all or any of the TRUSTEES as committee or Administrator or Managing Trustees or Trustees of otherwise) for the purpose of the Trust in such manner and subject to such rules and regulations as the TRUSTEES may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any property or any fund or investment subject to the provisions of this deed in such manner and subject to such rules and regulations as the TRUSTEES may from time to time fit.
- m) To start, abolish, discontinue and restart any charity or charitable institution for the benefit of general public and to impose any condition to any subscription or donation made by them.
